Dear Madam Secretary:

We are in receipt of a letter from the Oversight and the Education and Labor Committees Majority to you, dated March 29, 2019, seeking information and materials about the District of Columbia (D.C.) school voucher program authorized under the Scholarships for Opportunities and Results (SOAR) Act. They initiated this inquiry without consulting Republican Members of the Committee. As such, we write to request information to supplement the material they seek.

The SOAR Act offers residents of the District of Columbia educational choices by equally splitting funds between D.C. Public School (DCPS), D.C. Public Charter Schools (DCPCS), and a private school scholarship program.² A recent study found that a SOAR scholarship increased a D.C. student's probability of graduating high school by 12 percent, decreased a student's likelihood of chronic absenteeism by almost six percent, increased student satisfaction by almost nine percent, and increased a student's feeling of safety by almost 12 percent.³ Another study from 2007, showed that school choice leads to greater civic values—including political tolerance, volunteerism, and political participation.⁴

The SOAR program has bipartisan support at all levels of government. D.C. Mayor Muriel Bowser explained that "[t]he program has been instrumental in supporting the District's three-sector approach on education." During the most recent bipartisan reauthorization attempt

in 2016, eight of the thirteen members of the D.C. Council supported reauthorizing the program.⁶ In Congress, Senator Dianne Feinstein (D-CA) and Senator Cory Booker (D-NJ) support efforts to reauthorize the SOAR Act in 2019.⁷

The Trump Administration has proposed doubling SOAR Act funding for 2020 from \$45 million to \$90 million. This proposal is supported by Mayor Bowser. To help the Committee understand how the SOAR Act has improved educational opportunities for D.C. residents, we ask that you provide the following data and information:

- 1. The average cost per pupil in D.C. public schools compared to public schools nationwide;
- 2. The change, if any, in per-pupil cost for D.C. public schools since the implementation of the D.C. school scholarship program;
- 3. The average household income of D.C. school scholarship recipients;
- 4. For every year since its implementation, the total number of applications for D.C. school scholarships, listed by year and by grade;
- 5. The results of both student and parent satisfaction surveys from schools that participate in the D.C. school scholarship program;
- 6. The results of both student and parent safety surveys from schools that participate in the D.C. school scholarship program;
- 7. The graduation rates of students in D.C. public schools compared to schools that participated in the D.C. school scholarship program; and
- 8. The attendance rates of students in D.C. public schools compared to schools that participated in the D.C. school scholarship program.

We look forward to working with you and the Trump Administration to reauthorize this vital program and ensure that D.C. students receive the best possible education.
